## Vendor Rules & Regs

### VENDORS AGREE TO THE FOLLOWING:

- All Food vendors must have a copy of their OK Health Dept Food Handlers License
- All Vendors are responsible for reporting their own sales tax
- The vendor deals with the Harvest Fest Staff for power and booth extras directly. At least a 50 foot electrical extension cord will be needed to connect to power.
- The vendor is responsible for their booth to be set up and broken down. You can leave your booth setup overnight however this is at your own risk and we recommend you take all valuables!
- Fee includes access to the Vendors night on Thursday. Load in begins Wednesday-Thursday, all day-if you are not able to load in by Thurs you will not be able to bring a vehicle into the festival area on Friday after 8am. If you chose a space with camping behind your booth you must bring your camper by Wednesday. Vendors will be required to be open 10am to 10pm on Fri and Sat. Sunday Funday and Vendor Night Thursday is optional but encouraged especially for Merch Vendors.
- **ABSOLUTELY NO Cannabis** or any products containing any THC will be sold in or around the **ENTIRE** premises of the Camp Copperhead by any Harvest Fest vendor or representative of your business.
- Cannabis samples are **NOT** allowed to be distributed by any vendor.
- Harvest Fest is a 21 and over event-no exceptions due to Oklahoma **ABLE** licensure.
- No Medical ID Required to attend-only to purchase from the onsite dispensary.
- Vendors may purchase up to 4 staff passes at \$25 each during the time of booking **ONLY**-no exceptions so kindly respect this.
- Vendor add ons are available for camping behind your booth space for \$150. These are electric sites only, water for small campers will not be available at campsite, please fill your tanks before arrival.
- Pets are allowed in the campground only and require a pet pass. They must be leashed at all times and you must pickup after them. They may not be present in your booth area.
- You are allowed to bring your golfcarts, atvs and utvs. They must be permitted at the ticket office. They are only allowed in the festival area during load in or out.





# HARVEST FEST

Festival organizers and their respective Indemnitees shall not be held responsible, financially or otherwise, for any personal property that is left, lost, stolen, destroyed, confiscated, damaged or misplaced anywhere in the Venue or during the Festival, regardless of fault. You assume all risks of loss associated with the loss or damage to Your personal property.
